The above Order made on 2<sup>nd</sup> January 2025, if confirmed as made, will modify the Definitive Map and Statement for the area by deleting that part of Footpath W84 which extends from Church Lane at Grid Reference 44955 28786 in a generally westerly direction along the ancient holloway known as the Ridings for a distance of approximately 55 metres to the entrance to Claybrooke Cemetery at Grid Reference 44949 28786 (A-B pn Order Plan No. M1351) and also:

By adding Restricted Byway W134 along the ancient holloway known as the Ridings extending from Church Lane at Grid Reference 44955 28786 in a generally westerly direction past the entrance to Claybrooke Cemetery and continuing for a total distance of approximately of 155 metres to Woodway Lane at Grid Reference 44939 28787 (C-D on Order Plan No. M1351).
